- I authorize the Cambridge Public Health Department in partnership with Cambridge Public Schools to provide COVID-19 testing for ill children, using a technique with an anterior nasal swab.
- I acknowledge that a positive test result is an indication that my child must isolate as directed in an effort to avoid infecting others.
- I understand the health department is not acting as our medical provider. This testing does not replace treatment by our medical provider. I assume complete and full responsibility to take appropriate action with regards to my child’s test results.
- I agree our family will seek medical advice, care and treatment from our medical provider as needed, and especially if my child’s condition worsens.
