- I understand the health department is not acting as our medical provider. This testing does not replace treatment by our medical provider. I assume complete and full responsibility to take appropriate action with regards to my child's test results.
- I agree our family will seek medical advice, care and treatment from our medical provider as needed, and especially if my child's condition worsens.
- I authorize Cambridge Public Schools to release demographic data from my child's educational record required to facilitate the testing. This data includes, but may not be limited to; student ID, Name, DOB, Gender, Race, Ethnicity, Address, phone, and email.
