Ms. Sophia Green and Mr. Hersh Kanner, Student School Committee Representatives, welcomed the audience and special guests. They thanked the musicians (Amelia Bronfman and Emma Blanc & Itamar Baz) who performed while guests entered the Lecture Hall. The audience was invited to stand and join in saluting the flag with CRLS student Sophia Green. The audience remained standing for a rendition of the National Anthem sung by the CRLS Traveling Chorus, under the direction on Dr. Ivan Stefanov.

Ms. Green and Mr. Kanner acknowledged the newly elected Mayor, Sumbul Siddiqui; Vice Mayor, Alanna Mallon; honored City Officials; Dr. Salim, Dr. Turk and Cabinet Members.

Reverend Jaron Green of the Union Baptist Church gave the Invocation.

Ms. Rachael Rollins, Suffolk County District Attorney, was introduced as the keynote speaker. Ms. Rollins stated she is a proud daughter of Cambridge who attended the King School and her parents still live in North Cambridge. She spoke about achieving goals in 2020. Her administration has pushed for change even though it made people uncomfortable. They are working to decriminalize poverty, mental illness and substance abuse. She and DA Ryan of Middlesex County stood up to sue ICE to stop entering schools, churches and court houses which need to be places where people feel safe and are comfortable coming forward to help solve a case and not have to choose being sent back to somewhere or doing the right thing, it's always the right thing to protect yourself first. We are the only state in the United States of America where ICE can no longer make civil arrests. Education is the only way to stop crimes. Young people are the next generation to make changes.

Wael Alkhairo, CEO, Islamic Society of Boston, Cambridge and Roxbury gave the Benediction.
