Special Meeting February 4, 2025

Called for Tuesday, February 4, 2025 at 4:00 p.m. held in and broadcast from the Dr. Henrietta S. Attles Meeting Room, Cambridge Rindge and Latin School, 459 Broadway, to entertain a motion to convene in executive session for the purposes of discussing strategy for impact bargaining as part of collective bargaining (CEA Units A&B, C, D and E) as an open meeting may have a detrimental effect on the bargaining position of the School Committee.

## Mayor Simmons in the Chair

A quorum of the School Committee being present, the Chair called the meeting to order at 4:03 p.m.

The Chair read the call of the meeting and explained that this meeting is being televised, votes may be taken in executive session and the School Committee will reconvene in open session after the executive session.
