

## CAMBRIDGE SCHOOL COMMITTEE

## (Official Minutes)

Special Meeting June 25, 2021

Called for the purpose of approving and ratifying the contract for Dr. Victoria Greer as Interim Superintendent of Schools effective July 1, 2021.

A quorum of the school Committee being present, the meeting was called to order at 4:00 p.m.

The Chair asked for a roll call for the purpose of a sound check: Member Wilson YEA; Vice Chair Bowman ABSENT; Member Fantini YEA; Member Rojas; YEA; Member Rachel YEA; Member Weinstein YEA; Mayor Siddiqui YEA

The Chair opened the meeting for public comment. There being no one signed up for public comment, on a motion by Member Fantini, seconded by Member Weinstein, on the following roll call vote, it was voted to close public comment: Member Wilson YEA; Vice Chair Bowman ABSENT; Member Fantini YEA; Member Rojas; YEA; Member Rachel YEA; Member Weinstein YEA; Mayor Siddiqui YEA

**Mayor Siddiqui** provided background on the contract process, discussing that the School Committee met in Executive Session on June 1<sup>st</sup>, June 15<sup>th</sup> and June 22<sup>nd</sup> and the Committee has reached an agreement with incoming Interim Superintendent Dr. Victoria Greer effective July 1<sup>st</sup>, 2021. She thanked the Committee, Lisa Richardson, Melissa Murray from Norris & Peloquin LLC and Dr. Greer for their time and work throughout this process.

**Mayor Siddiqui** discussed the terms of the contract: contract starts July 1<sup>st</sup>, 2021 through June 30, 2022 and this agreement may be extended by mutual agreement and any extension will require formal approval from the Committee. During the initial term of this Agreement, the Interim Superintendent shall be paid a salary of \$230,000 (July 1, 2021 to June 30, 2022). She shared that the Committee and the Interim Superintendent will develop mutually acceptable goals and objectives, including measurable outcomes, for the 2021-2022 school year, taking into account the educational goals or policies established by the Committee. This retreat will be occurring only July 14.

**Member Rojas** clarified that if there is not an extension of the agreement that will not be considered a discharge. Mayor Siddiqui confirmed.

Member Wilson thanked the School Committee staff.

Mayor Siddiqui brought forward #21-225.

On a motion by Member Rachel, seconded by Member Wilson, on the following roll call vote, **#21-225** was adopted: Member Wilson YEA; Vice Chair Bowman ABSENT; Member Fantini YEA; Member Rojas; YEA; Member Rachel YEA; Member Weinstein YEA; Mayor Siddiqui YEA
