Dr. Greer presented <u>"Superintendent's Update: School Opening and ESSER Planning"</u>. Throughout the presentation topics discussed were: CPS's COVID Safety Plan and quarantine guidelines.

Mr. Maloney provided topics on pending clarifications that need to be and shared that the proposed language changes for COVID-19 Safety, Health & Facilities Manual will go through the Buildings and Grounds Sub-Committee.

**#21-280,** Grant Award, be adopted as follows: that the School Committee accept and approve the grant award below in the amount and for the period indicated.

FY22 Title I Distribution for the period September 1, 2021 to June 30, 2022 in the amount of \$1,105,409.00. Grant SC22604.

<u>Description:</u> The FY22 Title I grant will fund the program coordinator plus additional teaching staff at four elementary and two upper schools. Intervention teachers in math or ELA will serve at risk students at the Kennedy Longfellow, King Open, Morse and Fletcher Maynard Academy. At Cambridge Street Upper School, the grant will fund a 1.0 reading interventionist, and at Putnam Ave, the Title I grant will fund a 1.0 math interventionist and a .5 general interventionist. In addition, the grant will fund two half-time reading recovery teacher leaders who will provide professional development for all district early literacy interventionists, a 1.0 program manager/curriculum developer for an after-school STEAM program at 3 schools, a .33 social worker for homeless families, a 1.0 family liaison, and a .75 clerk. The grant budget also provides funding for summer school, community partners, parent involvement, and supplies, as well as services to eligible students in private schools.

**#21-281,** Grant Award, be adopted as follows: that the School Committee accept and approve the grant award below in the amount and for the period indicated.

FY22 ARP Homeless Children and Youth for the period September 1, 2021 to August 31, 2022 in the amount of \$26,015.00. Grant SC22709.

<u>Description:</u> This grant is funded by the Federal American Rescue Plan. It will fund .33 of the salary of a social worker to provide services for homeless children, youth and their families. Title I will fund another third of the cost of the social worker. In addition, funds for emergency supplies for these families are also provided.

**#21-282,** Grant Award, be adopted as follows: that the School Committee accept and approve the grant award below in the amount and for the period indicated.

FY22 McKinney Vento Homeless Students for the period September 21, 2021 to August 31, 2022 in the amount of \$10,000.00. Grant SC22707.

<u>Description:</u> This grant provides referral services for homeless children and their families through services of two Homeless Outreach Workers who connect families with resources and services throughout the school year and summer. It also provides for training by Transition Houses on domestic violence issues for school and community staff. Title I includes additional funds for serving homeless students.

**#21-283**, Grant Award, be adopted as follows: that the School Committee accept and approve the grant award below in the amount and for the period indicated.

FY22 Title III: English Language Acquisition for Limited English Proficient (LEP) Students for the period September 1, 2021 to June 30, 2021 in the amount of \$67,380.00. Grant SC22737. 

Description: This grant will fund four-week supplemental summer enrichment programs for English Language learners (ELLs) at the elementary and supper school levels. The programs will improve educational performance by assisting, these students to learn English and meet state academic content standards. It will also provide support for Ellevation (a software data and professional learning program), Parent ESL classes, online PD, and registration fees for Sheltered English Immersion (SEI) teachers to attend the annual MA conference for Teachers of Speakers of Other Languages Conference (MATSOL). ELLs at a private school who are assessed for eligibility will receive tutoring services on a proportional basis.

**#21-284,** Grant Award, be adopted as follows: that the School Committee accept and approve the grant award below in the amount and for the period indicated.

Gene Haas Foundation-RSTA Manufacturing Program for the period March 31, 2021 to February 28, 2023 in the amount of \$4,000.00. SC21145.

<u>Description:</u> This grant will be used to provide scholarships for graduates of RSTA's manufacturing program entering post-secondary study in machining-based engineering fields (\$2,000) and also to support student participation in Robotics competitions (\$2,000).

FY22 TURI-RSTA for the period September 1, 2021 to June 30, 2022 in the amount of \$10,000.00. Grant SC22173.

<u>Description:</u> The Toxic Use Reduction (TURI) at UMass Lowell has awarded the RSTA Automotive Department a grant to purchase equipment to reduce the use of toxic materials in the Automotive shop.
