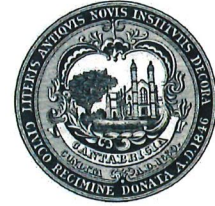

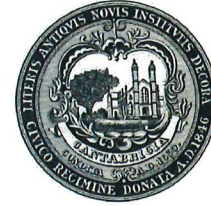

Description:

The Increase will be used for CPS mentor stipends; the rest of budget has been adjusted to reflect private school plan changes. Original text: As part of a comprehensive district initiative that focuses on the preparation, training, recruitment, and retention of highly qualified educators, Title IIA funds in FY22 will continue to support a .5 Instructional Coach for history/social studies teachers in grades K-5; the temporary salaries line will fund teacher stipends for mentoring (to be supplemented by Title IV funds); other expenses include professional development contracts for Math and the required allocation to participating private schools.
