Purpose: To provide technology infrastructure updating. This contract specifically addresses updates to the network switch infrastructure throughout the district. This will update a percentage of all switches throughout the district to ensure we remain on an acceptable replacement cycle for core infrastructure. This equipment is also ERATE eligible.

Amount of Contract: \$216,384.00

These expenses are eligible for partial Reimbursement under the Federal ERATE program.

General Fund: = \$86,553.60

Erate Funded:= \$129,830.40

Description/Scope of Services:

District Wide Partial Network Upgrade - This includes Juniper Network switches and associated peripheral electronics to replace aging equipment throughout the district. Total Cost = \$216,384.00

ERATE Program:

The Federal E-rate program was established many years ago by the Federal Communications Commission (FCC). The program is intended to assist schools in building technology capacity by covering some related costs.

The program has gone through many revisions over the years. Currently schools and libraries are eligible to receive discounts of eligible services related to Internet connectivity and certain network related costs. The eligible services are very limited compared to previous years. CPS currently receives E-rate discounts on the district's Internet costs and some network related hardware. This year the WiFi licensing and a portion of the firewall purchase are also eligible.

The rate of reimbursement may vary from 20% to 90% is based on a formula that takes into consideration a district's urban/rural status and "poverty level". CPS's reimbursement level recently seems to have stabilized at 60% for eligible services.
