SUPPLEMENTAL INFORMATION: Lesley University

Purpose: For the 2021-2022 school year, the Cambridge Public Schools have partnered with Lesley University to launch the pilot Early College Program, an opportunity for CRLS juniors and seniors to enroll in up to two Lesley University college courses as non-degree students eligible for college. The first cohort of students enrolled in courses offered by Lesley during the Spring 2022 semester.

Amount of Contract: \$35,725.00

Description/Scope of Services:

As part of the partnership overseen by the Office and Secondary Education and managed by the Early College Program Manager, Lesley University will provide the following services per this contract:

- Co-design the pilot program, including budget development, course design, scheduling, and administrative supports related to student enrollment.
- Enroll eligible CPS students in pre-selected "pathway" courses taught by Lesley University faculty to students who meet selection criteria for the pilot program and any Lesley University prerequisites.
- Collaborate with CPS to provide advising and counseling services to promote the successful transition of students into post-secondary education.
- Provide services and accommodations to eligible students with disabilities, consistent with Lesley University policies and procedures.
- Award university transcript credit to CPS students who successfully meet all expectations of their courses as set forth in Lesley University Academic policies or described by Lesley University instructors.

Per the Memorandum of Agreement between Lesley University and the City of Cambridge signed September 23, 2021, the Cambridge Public Schools will pay all expenses of the Pilot Program for the 2021-2022 pilot year. These costs include:
