Description/Scope of Services:

CPS went through an extensive process in SY23-24 to identify a system to replace the highly manual process and various spreadsheets needed to compile student-level information for MTSS meetings. This process included a combination of district, curriculum and school leaders who vetted the top system options to define both functionality and ease of use with an understanding of school-based needs. At the end of this process, the team recommended the MTSS system by **Branching Minds**, which was subsequently implemented across the district in SY24-25. Now, school-based intervention personnel are able to schedule meetings, create intervention plans and enter both data and notes about student interventions as they occur while simultaneously having access to all the data they need in one place.

The system is supporting a robust MTSS process at both the school and district levels in order to:

- 1. Identify students who are at risk across multiple indicators
- 2. Enable a more holistic view of student data
- 3. Create and track interventions for students that are at risk of not meeting grade-level expectations; this includes tracking who is providing the intervention, with what frequency, targeting what school, and monitoring the progress of this work.
- 4. Assess impact of interventions on individual and groups of students
- 5. Assess effectiveness of types of interventions
- 6. Track district-level performance towards MTSS specific goals.

This continued funding will allow us to deepen this work to further refine our practices around MTSS so that more students move toward grade-level expectations.
