

SUPPLEMENTAL INFORMATION: FY19/20 PJ Systems dba HiQ Computer Annual Technology Infrastructure Maintenance



Purpose: To provide annual technology infrastructure maintenance and support. This the ongoing maintenance of core networking and cyber security services listed below. To ensure timely processing and delivery, it is beneficial to have an open contract in place for the start of the fiscal year.

Amount of Contract: \$555,000

Some of these expenses are eligible for partial Reimbursement under the Federal ERATE program (Description attached).

General Fund:= \$358,200

Erate Funded: = \$196,800

Description/Scope of Services:

<u>Network/Professional Services</u> - Ongoing high level engineering services to assist with the monitoring and configuring of the CPS virtual server environment and enterprise backup - disaster recovery program, This totals \$30,000.

<u>SonicWall</u> - Annual licensing/maintenance fee for district firewall, web filter. This totals \$43,000 (Partially 60% Erate Reimbursed)

Backupify - Annual licensing fee to backup all user data stored in G-Suite. This totals \$15,000.

<u>Sophos AntiVirus:</u> Yearly subscription to allow antivirus endpoint protection for all CPS owned devices. This totals \$35,000.

<u>Ivanti</u> - Annual licensing for device management software to remotely manage all district's devices. This totals \$27,000.

<u>CISCO CloudLock:</u> Annual licensing for district GSuite for Education security software. Cloudlock provides tools to CPS to monitor and manage data security settings within G-Suite to ensure sensitive data is properly protected. This totals \$17,000.

<u>VEEAM Backup Solutions</u>: This solution will replace our current Backup Exec solution. This solution will allow us to efficiently backup our Virtual server environment as well as our individual servers. This totals \$10,000.

<u>Upgrade to Disaster Recovery Environment:</u> Storage devices that are part of the backbone infrastructure of the CPS Virtual Environment and play a role in the disaster recovery protection. The cost is: \$50,000

<u>Wireless Upgrades:</u> This purchase will complete a district wide 5 year wireless upgrade by upgrading all wireless infrastructure in the following schools; CRLS, FMA, Baldwin, Graham & Parks, Haggerty, Morse & Longfellow building this totals \$328,000 (60% Erate Reimbursed, leaving \$131,200 as CPS's share)

ERATE Program;

The Federal E-rate program was established many years ago by the Federal Communications Commission (FCC). The program is intended to assist schools in building technology capacity by covering some relates costs.

The program has gone through many revisions over the years. Currently schools and libraries are eligible to receive discounts of eligible services related to Internet connectivity and certain network related costs. The eligible services are very limited compared to previous years. CPS currently receives E-rate discounts on the district's Internet costs and some network related hardware. This year the WiFi upgrade and a portion (68%) of the firewall purchase are also eligible.

The rate of reimbursement may vary from 20% to 90% is based on a formula that takes into consideration a districts urban/rural status and "poverty level". CPS's reimbursement level recently seems to have stabilized at 60% for eligible services.
