SUPPLEMENTAL INFORMATION: Bunker Hill Community College

Purpose: Dual Enrollment Program with CRLS

Amount of Agreement: \$79,200.00

Description/Scope of Services: Bunker Hill Community College (BHCC) will partner with the Cambridge Rindge and Latin School (CRLS) to carry-out a Dual Enrollment Program.

This program strives to develop a higher education presence at CRLS and will provide CRLS students with opportunities to fulfill CRLS graduation requirements while attaining BHCC college credit.

As part of the program, BHCC and CRLS curriculum-aligned college-level English courses 111 and 112 will be offered during the 2022-2023 school year. A CRLS Massachusetts Certified Teacher, who is also cocertified as a BHCC Adjunct Faculty, will lead the courses. BHCC will compensate the teacher for his/her work. These courses will take place in-person on the CRLS campus.

During the fall semester of 2022, one section of College Writing I (BHCC 111) and one section of College Writing II (BHCC 112) will be offered. Up to 20 students may enroll in each section, for a total enrollment of 40 students.

During the spring semester of 2023, two sections of College Writing I (BHCC 111) will be offered. Up to 20 students may enroll in each section, for a total enrollment of 40 students.

All courses will align with and follow the Cambridge Public School (CPS) school year and daily schedules. CRLS will provide the required physical space, furniture, technical equipment, materials, and supplies necessary to carry-out the program.

For the fall and spring programming, the courses will be open to all CRLS students who have completed the 095 assessment.

BHCC tuition rates will apply for students enrolled. The current tuition rate is \$220 per credit. College Writing I and College Writing II are three-credit courses, for a per course tuition cost of \$660. classes.
