SUPPLEMENTAL INFORMATION: Wilson Language Corporation

Purpose: To provide training in Wilson Reading Program to private school staff and district teachers who provide services to private school students.

Amount of Contract: \$37,500 to be funded through *proportionate share requirements*¹ under the federal Individuals with Disabilities Act (IDEA) grants.

Description/Scope of Services:

Wilson will provide an onsite three day training to teachers on the Wilson Reading System. The Wilson Reading System is a phonics based tier III instructional program to develop students reading skills. Wilson Reading is a systematic approach that is structured and intentionally designed to meet students at their entry points, improve their decoding and encoding skills, and monitor their progress across grade spans. In addition, to the three onsite full day trainings, Wilson will train a cohort a 10 teachers who are interested in being a certified teacher through a rigorous online course over the next school year. They will provide instruction, coaching, and supervision to staff that participate in the certification process.

¹ **Proportionate share requirements:** Districts have an obligation to locate and evaluate students with disabilities enrolled by their parents in private schools located within the district, and to calculate and spend a proportionate share of federal special education (Individuals with Disabilities Education Act or IDEA) grant funds providing equitable services for these students. Privately-enrolled students include students at secular, non-secular, and independent schools, and home-schooled students.
