## SUPPLEMENTAL INFORMATION: Bunker Hill Community College

Purpose: Dual Enrollment Program with CRLS

Amount of Agreement: \$150,000.00

**Description/Scope of Services:** Bunker Hill Community College (BHCC) will partner with the Cambridge Rindge and Latin School (CRLS) to carry-out a Dual Enrollment Program. This program strives to develop a higher education presence at CRLS and will provide CRLS students with opportunities to fulfill CRLS graduation requirements while attaining BHCC college credit.

As part of the program, BHCC and CRLS curriculum-aligned college writing courses 1 and 2 will be offered during the 2025-2026 school year. A CRLS Massachusetts Certified Teacher, who is also co-certified as a BHCC Adjunct Faculty, will lead the courses. BHCC will compensate the teacher for his/her work. These courses will take place in-person on the CRLS campus.

During the Fall Semester of 2025-2026, the following course(s) will be offered:

#### College Writing 1

This course will be offered after-school on Monday and Wednesday at 3:15 p.m.

This course will be offered during the school day on Mondays and Wednesdays at 8:30 a.m.

CRLS student enrollment: 14

## College Writing 2 (Course E413BD-002)

This course will be offered during the school day on Tuesdays and Thursdays at 1:35 p.m.

CRLS student enrollment: 22

A total of 174 students are currently enrolled in the fall and spring semester course offerings.

Also, as part of the program, CRLS students who have completed the College Writing 1 course may take another BHCC course (led by a BHCC teacher), in another subject area, during the fall semester (2025) or spring semester (2026) at BHCC for college and high school credit. These courses may be taken in-person or through BHCC's online program. A CRLS Dean of Curriculum and/or Coordinator of Guidance will approve the student's enrollment in the course. Once approved, CRLS will cover the cost of the student's tuition. CRLS will budget for 6 additional courses, for a total of \$4,800.
